To be eligible for the **Volume Award**, agents must have closed volume of combined sales that have been reported to the Des Moines Area Association of Realtors® MLS System from January 1, 2018 through December 31st, 2018 of **\$11,016,000** million or greater.

To be eligible for the **Rookie Award**, it must be a participant's first full calendar year or first 12 consecutive months of licensure in the state.

This award will be presented to those who can verify volume of **\$7,711,200** million or greater in combined sales that have been reported to the Des Moines Area Association of Realtors® MLS system. A recipient may be eligible for the Rookie Award and the First-Year Circle of Excellence Award if he or she has qualified for such award. Rookie Awards will not be awarded to team members.

To be eligible for the **Unit Award**, you must be an agent who does not qualify for the Circle of Excellence Volume Award but have 50 or more combined Units closed in the calendar year 2018

Brokers Note: Your agents' eligibility for the Circle of Excellence Awards depends on the Broker/Owners providing to the Circle of Excellence Screening Committee a computerized list of each eligible Member's 2018 year end Volume and Units Sold. List must be received on or before January 11, 2019.

Agents Note: An application signed by the agent and Broker for the award they are applying for must be sent into the Board office no later than Tuesday, January 15, 2019.
